- 17-276** Motion by Councilman Berry, seconded by Councilman Kosinski, to concur with Mayor Paletko and approve the 2013-2018 Dearborn Heights Communication Officers Association Agreement and authorize the Mayor and City Clerk to sign the agreement on behalf of the City as outlined in Item 8-A.

After a brief discussion, the motion was amended by Councilman Berry, seconded by Councilman Abdallah, to refer the 2013-2018 Dearborn Heights Communication Officers Association Agreement to a closed session for further discussion. Per Mayor Paletko, communication dated July 24, 2017.

- 17-277** Motion by Councilman Kosinski, seconded by Councilman Muscat, to concur with Fire Chief Brogan's request and approve the Enterprise Fleet Management Lease Agreement to acquire two Ford F-250, 4X4 Super Cabs, and two Ford F-150, 4X4 Super Cabs, for an annual cost \$23,544.48 per year for all four vehicles as outlined in Item 9-A. These vehicles will replace two utility pickup trucks that are used at each Fire Station and two vehicles for Fire Prevention for the Fire Marshal and the Fire Inspector. This expenditure was budgeted for the 2017-2018 Budget. Per Fire Chief Brogan, communication dated July 25, 2017.

Motion adopted.

- 17-278** Motion by Councilman Muscat, seconded by Councilman Abdallah, to concur with Police Chief Gavin to approve and pay for the inspection and testing of the fire pump, dry pipe fire sprinkler system and all wet pipe fire sprinkler systems at the Justice Center by Associated Fire Protections Services as outlined in Item 9-B. The total cost of \$2,175.00 will be split with the Police paying \$1,413.75 and the 20th District Court paying \$761.25 out of the Contractual Services Account. Per Police Chief Gavin, communication dated July 25, 2017.

- 17-279** Motion by Councilman Kosinski, seconded by Councilman Muscat, to concur with the request of Public Service Administrator Zimmer and approve the purchase and payment upon completion of software programs and training for the sign making machine from TAPCO (Traffic and Parking Control Inc.) as outlined in Item 9-C. The quote of \$3,695.00 is U. S. Communities Government Purchasing Alliance pricing. Funds for this expenditure have been allocated in the approved 2017-2018 Budget. Per Public Service Administrator Zimmer, communication dated July 31, 2017.
